14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ On May 22, 2017, the Henderson High Yield Opportunities Fund ("Acquired Fund") merged into the T. Rowe Price U.S. High Yield Fund ("Acquiring Fund") in a tax-free reorganization. Pursuant to the terms of the merger, shares of the Acquired Fund were exchanged for shares of the Acquiring Fund based on the valuation date of the shares on May 19, 2017.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ A shareholder's aggregate basis in the shares of the Acquiring Fund will be the same as their aggregate basis in shares of the Acquired Fund that were surrendered in exchange for shares of the Acquiring Fund.
