

# 2025 Janus Henderson Funds FINAL Per Share Distribution Amounts

Attached are the final per share distribution amounts paid on December 9, 2025 to shareholders of record on December 8, 2025 for the Janus Henderson fixed income funds listed below.

The funds intend to distribute the maximum amount of dividends qualifying for the 15% rate allowable under the law.

Please note that Funds that have invested in real estate investment trusts (REITs) during the current tax year may potentially recharacterize some of their income distributions as return of capital. If applicable, the recharacterization may occur in February following the current tax year.
