

## 2022 Foreign Taxes Paid

Foreign taxes paid by a mutual fund and passed through to its shareholders may be eligible for a federal tax deduction or credit. For 2022, the following portfolios qualified for and made the election to pass through foreign taxes paid by each portfolio to investors (the amount shown in Column 27 of the "Janus Henderson VIT ICI Primary Layout 2022" spreadsheet). ## 2022 Percentage of Dividends Eligible for the Corporate Dividends Received Deduction

Mutual fund dividends derived from certain domestic corporations may be eligible for the dividends received deduction (DRD) for corporations. A portion of the ordinary income dividend (Column 14 plus Column 15 of the "Janus Henderson VIT ICI Primary Layout 2022" spreadsheet) paid in 2022 may qualify for this deduction. The table below shows the portion of the ordinary dividends attributable to such domestic corporations.
