

2023 Foreign Taxes Paid

Foreign taxes paid by a mutual fund and passed through to its shareholders may be eligible for a federal tax deduction or credit. For 2023, the following portfolios qualified for and made the election to pass through foreign taxes paid by each portfolio to investors (the amount shown in Column 27 of the "Janus Henderson VIT ICI Primary Layout 2023" spreadsheet).
