

2025 Janus Henderson Estimated Per Share Distribution Amounts

The Janus Henderson preliminary year-end distribution estimates to be paid in December 2025 are shown below.

Please note that these estimates were prepared using income and capital gain amounts through **September 2, 2025**. The distribution amounts may change, perhaps significantly, for the following reasons:

1. The funds are required to distribute capital gains recognized through October 31, 2025. The funds may realize additional capital gains and losses during the period September 3rd through October 31st.
2. The funds are required to distribute income earned through December 31, 2025. The dividend estimates include income through September 2nd. They do not include estimates of income during the period September 3rd through December 31st which will also be distributed in December 2025.
3. The total number of shares which will receive the distribution will change, perhaps significantly.

The regular monthly dividend for the Janus Henderson Developed World Bond Fund is payable on December 31, 2025.

The funds intend to distribute the maximum amount of dividends qualifying for the 15% rate allowable under the law. Estimates of the qualifying percentage are not yet available.

Please note that Funds that have invested in real estate investment trusts (REITs) during the current tax year may potentially recharacterize some of their income distributions as return of capital. If applicable, the recharacterization may occur in February following the current tax year.
